Second Safeguarding Adults Reviews Analysis 2019-2023

Second Safeguarding Adults Reviews Analysis 2019-2023 Webinar

Tuesday 14 May 2024 - 10.00am - 12.00pm

This webinar will present the results of the second national analysis of safeguarding adult reviews in England. It will present a detailed analysis of the types of abuse and neglect, and the nature of adult safeguarding concerns as reported in 652 reviews. This analysis will offer both a regional and a national perspective. Some comparisons will be made with the first national analysis. The webinar will then present the findings and recommendations from a stratified sample of 229 safeguarding adult reviews across five domains – direct practice, the team around the person, organisational support for practice, governance and the national context within which adult safeguarding is situated. Finally, some suggestions will be offered for improvement priorities.

Modern Slavery Update Year end 31 dec 2023

Please see attached a document with the headlines from the National Referral Mechanism (NRM) and Duty to Notify (DtN) statistics end of year summary 2023 which was published on 7 March 2024. It provides a summary and breakdown of the number of potential victims of modern slavery referred into the NRM or via the DtN process from 1 January to 31 December 2023.

NRM and DtN statistics are used to build a picture of the potential scale of potential victims of modern slavery in the UK. As the data relates to potential victims identified by first responders and referred into the NRM and DtN, it does not capture all victims of modern slavery in the UK. There is likely to be a large number of unidentified potential victims given the hidden nature of modern slavery.

The attached document details the national and local perspective which you might find helpful when delivering safeguarding training to help raise awareness amongst all staff.



Local Perspective: Surrey (1 January - 31 December 2023)

- Between 1 January 31 December 2023, Surrey Police referred 74 potential victims of modern slavery to the NRM. The previous annual total was 80 in 2022 and 74 in 2021. Of the 74 potential victims, there were 43 adults, 27 children and 4 were recorded as not specified or unknown.
- Surrey Police were responsible for the criminal investigation of a total of 172 potential victims of modern slavery in 2023. The previous annual figure for 2022 was 187 and 137 in 2021. Of the 172 potential victims, there were 97 adults, 67 children and 8 were recorded as not specified or unknown.
- The most common type of exploitation for adults was labour exploitation (31%: 23/74) followed by criminal exploitation (15%: 11/74).
- The most common type of exploitation for children was criminal exploitation (26%: 19/74) followed by sexual exploitation (8%: 6/74).
- In Surrey, the three most common nationalities identified as potential victims of Modern Slavery that have been referred to the NRM are:

- UK nationals (47%: 35/74),
- Ghanian (18%: 13/74)
- Albanian (10%: 7/74)

For Health, the government's approach is focused on ensuring all healthcare staff are able to identify individuals who may be victims of trafficking, and to respond in an appropriate manner. This includes understanding ways in which healthcare staff can provide support to those who may be victims.
