## Recordings from Safeguarding PLT events

Dear colleagues

We have now delivered the fourth and final safeguarding update for GP clinical staff. You may recall that we delivered one programme to Guildford and Waverley and East Surrey in September 2023, and we have now delivered the second programme to North West Surrey and Surrey Downs. A big thank you to the GP tutors and their teams for all their support in providing these sessions.

One of each pair has been recorded, and both recordings are now available on the Surrey Training Hub. Session 1 covers Helping Surrey Families Early (the role of the early help hub), domestic abuse update (high risk DA and non-fatal strangulation, specialist DA outreach provision, the Interventions Alliance perpetrator programme) and safeguarding arrangements in Surrey GP practices; what does "good" look like?

Session 2 covers the role of Police in a adult safeguarding (general overview, the police response to DA, tackling anti-social behaviour and cuckooing), the C-SPA and MAP team in children's service, non-accidental injuries in children and the ICON programme.

The intention is that accessing both of these sessions (either one live + one recording, or two recordings) will provide you with the same amount of participatory level 3 child and adult safeguarding update training as our pre-pandemic one day events did.

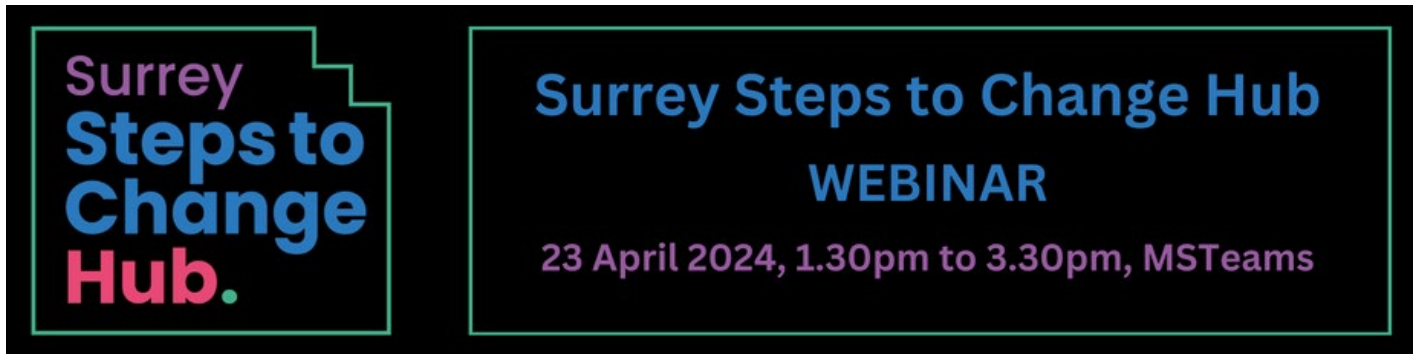

The Office of the Police and Crime Commissioner, working with partners, secured almost £2m from the Home Office Domestic Abuse Perpetrator Interventions Fund to commission services during 2023-25. The overall aim is improve the safety of victims by reducing the risk posed by domestic abuse and stalking perpetrators, as well as children and adolescents who use abuse/violence in their relationships and to prevent reoffending in future.

We invite you to join a webinar to learn how the partnership has established the Surrey Steps to Change Hub, a brand new collaboration of services, expert in increasing survivor safety and reduction of harm. Through attending this webinar, you will learn about the services the hub can offer, get to meet the people involved and understand how they work together for positive and sustained change. The hub is a gateway to interventions for anyone over 11 years of age using harmful behaviours in their close relationships or anyone 16+ seeking support to change stalking behaviour in any context. This will include perpetrators of domestic abuse or stalking who are arrested by police but not charged, those subject to a police investigation, or those who may have committed an offence which is appropriate for a formal out of court disposal. All services are accompanied by integrated support for survivors.
